#### Aims of the workshop

We anticipate that by the conclusion of the workshop, cities will have clearly defined key takeaways. Our goal is to ensure that participants leave with a comprehensive understanding of the discussions and a plan for implementation in their respective cities.

**Day 2 (all cities):** An overview of disaster response and recovery assessment, adaptation and resilience assessment, risk management/ mitigation roadmap, and risk pool mechanism.
