In order to join ICLEI, a local government is asked to contribute a modest annual fee. The amount of this annual fee varies depending on your country, its GNI per capita, and its population.

¹ The basic membership fee in China includes the core benefits as an ICLEI Member including the access to ICLEI's global network, participation in events, and access to basic resources etc. If additional services, such as language support, tailored coordination and training etc., are requested by a member, the additional service charges will be discussed and confirmed case by case. To reduce administrative costs, a Member that pays its membership fee for three years in one lump sum will enjoy a 5% discount.
